Horses are living creatures, they can be frightened at any time and their behaviour can be unpredictable. For this reason, riding is classified as a Risk Sport.

Your Choice to Ride is Voluntary and is at your Own Risk.

We are making you aware that anybody riding or near a horse / pony can suffer bodily or other injuries and that each year people incur fatal injuries while riding or handling horses.

Liskennett Equestrian Centre takes all reasonable care to provide suitable and safe horses / ponies for all our Service Users. But, horses are unpredictable by nature. For example when frightened, angry or under stress, a horse's natural instincts are to jump forward or sideways, or run away from danger by trotting or galloping. Horses/ ponies are also known to kick, buck, rear- up or bite. Horses are also powerful and potentially dangerous.
